**Prevention:**

**Response:**

**If inhaled:** Remove person to fresh air and keep comfortable for breathing. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.  
**If on skin:** Wash with plenty of water. **If skin irritation or rash occurs:** Get medical attention. Take off contaminated clothing and wash before reuse.  
**If in eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes for at least 15 minutes. Obtain medical attention without delay, preferably from an ophthalmologist.  
Get medical attention/advice if you feel unwell.

**Storage:**

Store in a cool, dry, well ventilated and secure area designated specifically for pesticides and away from heat sources.  
Keep in original containers and keep containers closed when not in use.

### Section 4: First-Aid Measures

**Have the product container or label with you when calling a poison control center or doctor, or going for treatment.**

**Eye Contact:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes for at least 15 minutes.

**If Swallowed:** Call a poison control center or doctor immediately for treatment advice. Rinse mouth with water then have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious or convulsing person. Have product label with you when calling a poison control center or doctor.

**Skin Contact:** Immediately flush skin with water for 15 to 20 minutes while removing contaminated clothing and shoes. Get medical attention if symptoms occur. Wash clothing before reuse. Destroy contaminated leather items such as shoes, belts, and watchbands.

**If Inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

### Section 5: Fire Fighting Measures

**Fire Hazards:** Closed containers may rupture if exposed to excess heat or flame due to a build-up of internal pressure. Thermal decomposition during a fire can produce fumes and irritating gases.

## Section 6: Accidental Release Measures

### Steps to be taken if Material is Released or Spilled:

## Section 7: Handling and Storage

### KEEP OUT OF REACH OF CHILDREN

**Handling:** **General Handling:** Avoid contact with eyes, skin, and clothing. When using do not eat, drink or smoke. Wash thoroughly after handling. Do not swallow. Avoid breathing vapor. Use with adequate ventilation. Wear long sleeved shirt, long pants and boots with socks when handling. Keep away from heat, sparks and flame. **Exposure Limits:** TLV 10 ppm Metolachlor

### Personal Protection:

**Eye/Face Protection:** Wear safety glasses with side shields or chemical splash goggles to prevent vapors or mists from entering the eyes. If using a full face shield, always use safety glasses or goggles along with the face shield to ensure adequate protection of the eyes.

**Skin Protection:** Use protective clothing chemically resistant to this material. Selection of specific items such as face shield, boots, apron, or full body suit will depend on the task. Safety shower should be located in immediate work area. Remove contaminated clothing immediately, wash skin area with soap and water, and launder clothing before reuse or dispose of properly. Items which cannot be decontaminated, such as shoes, belts and watchbands, should be removed and disposed of properly.

**Hand protection:** Use gloves chemically resistant to this material. Examples of preferred glove barrier materials include: Neoprene, Nitrile/butadiene rubber ("nitrile" or "NBR") or Polyvinyl chloride ("PVC" or "vinyl").

**Respiratory Protection:** Respiratory protection should be worn when handling in enclosed areas, when large quantities of mists are generated or prolonged exposure is possible. Use a respirator with either an organic vapor-removing cartridge with a pre-filter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C) or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G).

**Ingestion:** Avoid ingestion of even very small amounts; do not consume or store food or tobacco in the work area; wash hands and face before smoking or eating.

**Ventilation:** Handle this product in a well ventilated area. Ventilate all transport vehicles prior to unloading. Facilities storing or utilizing this material should be equipped with and eyewash facility and safety shower.
